ORDINANCE NO. 080309

AN ORDINANCE VACATING NOR POLE ROAD

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Orange Township, Columbia County, Pennsylvania, that Township Route 572, also known as Nor Pole Road, is hereby vacated in its entirety from State Route 4041 (Rohrsburg Road) to State Route 0487.

Said Nor Pole Road is identified on a copy of the August 21, 1997 survey draft of Frank E. Beishline, P.L.S., which is attached hereto, made part hereof, and marked Exhibit A.

This Ordinance shall take effect thirty (30) days after enactment.

ENACTED this 3rd day of August, 2017.

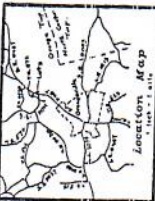

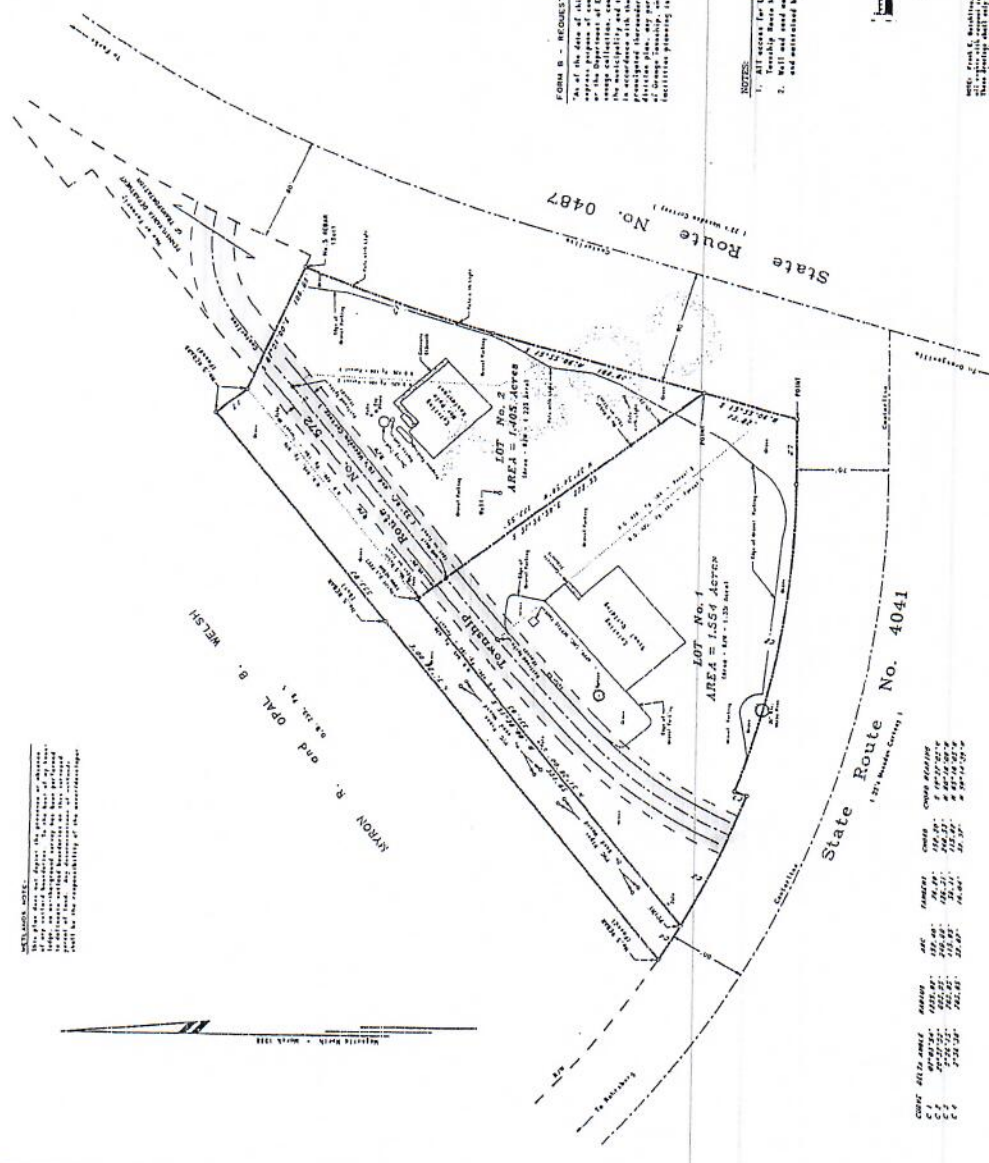
