**ORDINANCE NO. 1999-02**

**AN ORDINANCE ESTABLISHING MAXIMUM SPEED  
LIMITS ON CERTAIN ROADS WITHIN ORANGE  
TOWNSHIP.**

WHEREAS, Section 3362(a)(2) of the Pennsylvania Vehicle Code, 75 Pa.C.S.A. §3362, establishes a maximum speed limit of 55 miles per hour for rural roads unless a reduced speed limit is established by the governmental entity having jurisdiction over such roads; and

WHEREAS, the Board of Supervisors of Orange Township has caused a traffic study to be performed on certain roads within the Township which indicates that the existing maximum speed limit of 55 miles per hour is excessive and unsafe and that reduced maximum speed limits would be more appropriate based upon the condition of the roads and the nature and volume of traffic using them; and

WHEREAS, the Board of Supervisors of Orange Township has determined that reducing the maximum speed limit on certain Township roads as provided hereafter will promote the public safety and general welfare of the residents of Orange Township.

NOW, therefore, the Board of Supervisors of Orange Township hereby **ORDAINS AND ENACTS** the following maximum speed limits on certain roads within Orange Township:

1. The maximum speed limit on Whitmire Road (T-525) for a distance of 0.3 mile between Draketown Road (SR-1013) and the North Centre Township line shall be 25 miles per hour.

2. The maximum speed limit on Sponenburg Hill Road (T-564) for a distance of

0.3 mile between Draketown Road (SR-1013) and Lightstreet - Fowlersville Road shall be 25 miles per hour.

3. The maximum speed limit on Hartman Hollow Road (T-575) for a distance of 1.7 miles between Rohrsburg Road (SR-4041) and Bowman's Mill Road (SR-4037) shall be 30 miles per hour.

4. The maximum speed limit on Deitterick Road (T-560) for a distance of 0.5 mile between Lightstreet - Fowlersville Road and Eckroth Road (SR-1010) shall be 25 miles per hour.

5. The maximum speed limit on McHenry Hill Road (T-561) for a distance of 1.2 miles between Kline Road (T-551) and Bowman's Mill Road (SR-4037) shall be 30 miles per hour.

6. The maximum speed limit on Welliverville Road (T-559) for a distance of 0.6 mile between Bowman's Mill Road (SR-4037) and the Mount Pleasant Township line shall be 30 miles per hour.

7. The maximum speed limit on Bartholomew Road (T-518) for a distance of 0.5 mile between Black Road (T-575) and Welliverville Road (T-559) shall be 30 miles per hour.

8. The maximum speed limit on Black Road (T-575) for a distance of 0.8 mile between Bowman's Mill Road (SR-4037) and the Mount Pleasant Township line shall be 30 miles per hour.

9. The maximum speed limit on Sportsman Club Road (T-569) for a distance of 1.0 mile between Rohrsburg Road (SR-4041) and the Fishing Creek Township line shall be 25 miles per hour.


This Ordinance shall become effective five (5) days after enactment in accordance
