**ORDINANCE NO.** 1999-01

**AN ORDINANCE AUTHORIZING THE ERECTION OF  
CERTAIN TRAFFIC CONTROL DEVICES AT THE  
INTERSECTIONS OF CERTAIN ROADS WITHIN  
ORANGE TOWNSHIP.**

WHEREAS, Section 6124 of the Pennsylvania Vehicle Code, 75 Pa.C.S.A. §6124, authorizes local municipalities to erect and maintain traffic control devices at the intersections of roads within their jurisdiction; and

WHEREAS, the Board of Supervisors of Orange Township has caused a traffic study to be performed of certain roads within the Township which indicates that the erection and maintenance of certain traffic control devices at the intersections of certain roads within the Township will be appropriate based upon the condition of the roads and the nature and volume of traffic using them; and

WHEREAS, the Board of Supervisors of Orange Township has determined that erecting and maintaining certain traffic control devices as set forth hereafter will promote the public safety and general welfare of the residents of Orange Township.

NOW, therefore, the Board of Supervisors of Orange Township hereby ENACTS AND ORDAINS as follows:

1. A stop sign shall be erected and maintained on Trump Road (T-551) at its intersection with Hartman Hollow Road (T-575).
2. Stop signs shall be erected and maintained on both sides of Gass Road (T-559)

at its intersection with Hartman Hollow Road (T-575).

3. A stop sign shall be erected and maintained on Montague Hollow Road (T-559) at its intersection with Hartman Hollow Road (T-575).

4. A stop sign shall be erected and maintained on Montague Hollow Road (T-559) at its intersection with Bowman's Mill Road (SR 4037).

5. A stop sign shall be erected and maintained on Bartholomew Road (T-518) at its intersection with Black Road (T-575).

6. A stop sign shall be erected and maintained on Oman Road (T-568) at its intersection with Kline Road (T-551).

7. A stop sign shall be erected and maintained on Trump Road (T-551) at its intersection with Kline Road (T-551).

8. A yield sign shall be erected and maintained on Kline Road (T-551) at its intersection with McHenry Hill Road (T-561).

9. Stop signs shall be erected on Oman Road (T-568) on both sides of its intersection with McHenry Hill Road (T-561).

10. A stop sign shall be erected and maintained on Oman Road (T-568) at its intersection with Bowman's Mill Road (SR 4037).

11. A stop sign shall be erected and maintained on Crouse Hollow Road (T-512) at its intersection with Fester Road (T-551).

12. A stop sign shall be erected and maintained on Hack Road (T-516) at its intersection with Fester Road (T-551).

13. A stop sign shall be erected and maintained at the end of the circle on

Longview Drive.

14. A stop sign shall be erected and maintained on Longview Drive at its intersection with Deitterick Road (T-580).


15. A yield sign shall be erected and maintained on Megargell Road (T-523) at its intersection with Buck Road (T-521).

16. A yield sign shall be erected and maintained on Moore Road (T-563) at the Dane Albertson residence.


This Ordinance shall become effective five (5) days after enactment in accordance with Section 1601(a) of the Second Class Township Code.
